SSTV Tips

A few years ago, I published some SSTV operation tips to help improve operation skills. Because new members are learning SSTV operations, I thought it would be valuable to provide this information again as a review in taking meaningful pictures and operating the Kenwood VCH-1. Here is "Part 2" continuing from my article in the last edition of Net Control.

How many times have you heard an SSTV receiving station say to you "can you send your picture again and remove the word KENWOOD or your call sign from it?" Your immediate response, how do I do that?

This is one tip you might attach to your VCH-1. By following the simple steps below, you will be able to turn "ON" or "OFF" the VCH-1 character generator.

Character Generator – Verify VCH-1 is in "OFF" condition. Press and hold down the MR and HOLD buttons together. Switch the VCH-1 power to "ON". Each time repeated, the VCH-1 character generator will toggle "On" or "OFF".

To change the word KENWOOD stored in the character generator to your call sign, simply overwrite KENWOOD by stepping through the alphabet using the "TX" or "RX" buttons to select alphanumeric characters. Press the "MR" button to move the cursor to the next character. Press the "HOLD" button when completed. Your call sign is now stored for future reference.

When sending SSTV pictures try to keep the transmitting antenna steady or picture quality may experience noise when sending stations have a weak signal. Always check and test your equipment regularly to make sure it is mission ready. It is better to plan now than during a real event. This also helps reduce stress!

New OCRACES Program Coordinator

OCSD/Communications has announced the appointment of Marten Miller, KF6ZLQ, to the position of Emergency Communications Coordinator. This position was previously held by Robert Stoffel, and Marten now becomes the new OCRACES Program Coordinator.

Marten has worked for the County of Orange for 20 years. He began as a Communications Coordinator II with Control One following four years as a Radioman in the United States Navy. He was promoted to a Supervising Communications Coordinator in May of 1988, and was promoted to the position of Communications Training Officer in February of 1999. Over the past six years, Marten has had the lead responsibility for training City and County law enforcement, fire services, life-guard, paramedic and public works personnel on the operation of the 800 MHz system. Marten has also done a phenomenal job of coordinating our election support activities, as well as interfacing with the Health Care Agency, Emergency Management, and other organizations in the support of emergency communications.



SAN DIEGO BPL UPDATE

May 10, 2005 - According to a representative of San Diego Gas and Electric Company, SDG&E's plans for testing Broadband over Power Line ("BPL") technology on a portion of SDG&E's power grid are progressing smoothly. At least 30-days notice of the actual testing will be provided to the public as required by Section 15.615 of the FCC Rules. The information that must be provided includes not only the zip codes of the test zones, but the frequencies to be used, the manufacturer and type of equipment to be used and the proposed or actual date of the operation/s. The list of zip codes slated for testing is said to be nearing completion. SDG&E currently plans to release the entire zip list all at once when the necessary bits and pieces come together. So far, we have no hint as to which geographic areas will be tested. It is possible that SDG&E will test only one BPL system at the outset and use only a small geographic area, but nothing is definite. SDG&E reemphasizes its willingness to work with all potentially affected parties.

FIBER OPTICS IN LIVE GAS LINES PROPOSED

This web posting (<http://www.semprafiberlinks.com/Pages/Home/Home.aspx>) is of more than routine interest since Sempra Fiber is owned by Sempra Energy which owns San Diego Gas and Electric, the entity that will soon be testing BPL in San Diego. *"Sempra Fiber Links introduces a unique solution to the last mile bottleneck for optic fiber networks. We've developed a new and exciting process to safely route fiber-optic cable and conduit to buildings through existing, live natural gas pipelines. That's right. Active, live natural gas pipelines. So fiber-optic networks can easily go places difficult to reach before. Faster. With less excavation and disruption."*

NEWS FROM THE FEDERAL COMMUNICATIONS COMMISSION

The FCC has picked Kevin J. Martin to succeed the agency's outgoing chairman Michael K. Powell. Martin does not require Senate confirmation as he is already a Commission member. Indications are that Martin will continue the FCC's more stringent enforcement of indecency regulations and may be more open to concerns about interference from broadband over power lines (BPL).

One Republican seat is open on the five-member commission, but the third Republican commissioner, Kathleen Q. Abernathy, may also choose to step down later this year. Democratic commissioner Jonathon S. Adelstein was recently reappointed to a five-year term; Democrat Michael J. Copps term expires in June but may be renominated.
